How to buy on OPENLANE.com using your AFC Floorplan:

When bidding on a vehicle, select "Pay with AFC" as your payment option. OPENLANE.com will submit your request to floor this vehicle immediately upon the auction close, and OPENLANE.com and AFC will take care of the rest. In the event of insufficient available credit or dealer's access to credit has been nullified by AFC, dealer will be notified and then the dealer must send a check to OPENLANE.com within three (3) business days of the online purchase date. For vehicles floored with AFC, titles will be sent directly to AFC.

Registration

To use your AFC floorplan, simply submit the attached Dealer Payment Form. Within 48 hours, OPENLANE.com and AFC will work together to enable your AFC account on OPENLANE.com. Once you are set up, there is no need to call AFC to request flooring an OPENLANE.com purchase again.

With your AFC line added, you can still pay using the other payment methods you've signed up for including FastLane/ACH, Wire to OPENLANE.com, and Dealer Check.
